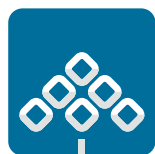

POLL RESULTS OF ANNUAL GENERAL MEETING HELD ON 28 MAY 2021

The Board is pleased to announce that the resolutions as set out in the notice of AGM were put to the AGM for voting by poll and approved by the Shareholders including, inter alia, the proposal of the payment of final dividend and the grant of general mandates to issue and repurchase Shares.

POLL RESULTS OF ANNUAL GENERAL MEETING

The board of directors (the “**Board**”) of Country Garden Services Holdings Company Limited (the “**Company**”) is pleased to announce that the resolutions as set out in the notice of annual general meeting of the Company dated 27 April 2021 were put to the annual general meeting of the Company held on 28 May 2021 (the “**AGM**”) for voting by poll and duly approved by the shareholders of the Company (the “**Shareholders**”).

The Company’s Hong Kong branch share registrar and transfer office, Tricor Investor Services Limited, was appointed as scrutineers for the purpose of counting the votes at the AGM.

As at the date of the AGM, the total number of issued shares of the Company (the “**Shares**”) being the total number of Shares entitling the Shareholders to attend and vote for or against all the resolutions proposed at the AGM was 3,073,788,221 Shares. There were no Shares entitling the Shareholders to attend the AGM and abstain from voting in favour of the resolution(s) pursuant to Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”). There were no Shareholders that were required under the Listing Rules to abstain from voting. None of the Shareholders had stated his/her/its intention in the Company’s circular dated 27 April 2021 to vote against any of the resolutions proposed or to abstain from voting at the AGM.
